Roll Call & Report of Public Meeting Notice

New WIOA Policies & Processes - Mari Kay-Nabozny, NWWIB CEO & Jeff Muse, CEP Executive Director

Mari Kay-Nabozny discussed the outdated WIOA policies based on the DOL monitoring. The WIB will redo all the new WIOA policies which will mirror the state WIOA policies. CEP will maintain a process manual for their staff and the WIB will keep the policies up to date. Mari noted that we have to provide the state with a draft timeline. Jeff Muse noted this helps CEP to follow up with proper procedure.

WIOA Quarter 2 Enrollment Update & Corrective Action

Update on New NWWIB Hire

Discuss WIOA Youth Procurement

This WIOA RFP is for ISY and OSY funds. There are three pieces to the RFP. It's due March 28th. She explained that there's a stand-alone element and flexibility to serve ISY.

Discuss One Stop Operator (OSO) Procurement

Mari explained that the NWWIB is the OSO and coordinates all the OSO partners. The NWWIB procure for this.

Discuss OSO MOU

The OSO MOU is signed on an annual basis and is approved by the Consortium.

Workforce Advancement Initiative Grant (WAI) Metrics

WAI are part of the AARPA funds. Mari noted there are four sub-contractors on this grant. She noted it's going very well and CEP is doing a great job getting clients enrolled for assistance.

NWWIB New Approved Strategic Plan

Mari explained that the WIB approved their new strategic plan in December to align with the Governor's workforce initiatives.

NWWIB Annual Report

Mari reported that she mailed the NWWIB's annual report to the entire Consortium. She has it electronically and has hard copies for those who didn't receive one.

Charlie Glazman discussed the WIB presentation he attended in Superior on 2/14.
